

Information to be provided and request for consent

- The (EU) Regulation 2016/679 of the European Parliament and Council regarding the protection of natural persons in relation to the processing of personal data, as well as the free circulation of said data (General regulation on data protection, - "GDPR")

The personal data provided voluntarily will be processed, mainly electronically, by " European Movement International - the data controller - with an office at Place du Luxembourg 2, 1050 Brussels, Belgium" exclusively within the framework of the project JUST EU and ME (number 101081227) funded by the European Union's Citizens, Equality, Rights and Values (CERV) Programme (2021-2027), project aimed at empowering young people (18-30 years old) and representatives of youth associations with knowledge, skills and opportunities for actively participating in developing recommendations to improve EU and Member States policies implementing the European Pillar of Social Rights and addressing social justice issues.

The data collected are indispensable for the above-mentioned purpose and in their absence the activity cannot be carried out. Pursuant to article 9 of European Regulation 2016/679 (GDPR) one may confer data which qualifies as "special categories of personal data" (art. 9, paragraph 1, GDPR: "personal data that reveals racial or ethnic origin, political opinions, religious or philosophic beliefs or trade union membership. It also refers to the processing of genetic data, biometric data used to identify a specific natural person, data on health or a person's sex life or sexual orientation"). This data may be legally processed by us exclusively following free and explicit consent (art. 9, paragraph 2, letter a), GDPR).

The personal and identification data collected shall only be held for the time necessary for the completion of the project JUST EU and ME in its various stages and other instrumental activities (accounting and evaluation).

The Data processor is Alex Pitts.

The persons authorised to process the data for said purposes are members of staff working on the project and our associations institutional and communication activities, as well as those responsible for our IT systems and data security. The data may be processed by third parties for instrumental purposes with reference to the project partners for the execution of the various phases of the project itself as indicated in the Memorandum of Understanding among partners.

Pursuant to articles 15-22, GDPR, by writing to the data controller at the above address or by e-mail to secretariat@europeanmovement.eu one can request a complete and updated list of data processors and exercise the rights of consultation, modification, cancellation and the "right to be forgotten", as well as impose limitations to the processing of data or oppose said processing for legitimate reasons or for information and promotional purposes, also limited to one or more contact tools (e.g.: by e-mail and/or sms and/or post and/or telephone). If not specified, the objection to the



processing of data for information purposes shall be deemed to extend to all means of contact. Any revocation of the consent given, which may be submitted at any time, shall not affect the lawfulness of the processing based on the consent previously given or on alternative mechanisms to consent permitted by law.

One is also entitled to submit a complaint to the supervisory authority ((Autorité de protection des données / Gegevensbeschermingsautoriteit- Rue de la Presse 35 / Drukpersstraat 35 1000 Bruxelles / Brussel BELGIUM - https://www.dataprotectionauthority.be/citizen - e-mail: dataprotectionauthority.be) to assert his rights.
