

## **JUST EU and ME**

(number 101081227) funded by the European Union's Citizens, Equality, Rights and Values (CERV) Programme (2021-2027)

Information to be provided and authorisation for the dissemination of images, sounds and testimonies

The (EU) Regulation 2016/679 of the European Parliament and Council regarding the protection of natural persons in relation to the processing of personal data, as well as the free circulation of said data (General regulation on data protection, - "GDPR") provided.

# Information to be provided pursuant to art. 13 GDPR (European Regulation 2016/679)

The collected personal data (personal details, identification, images in video and photographic formats, as well as sounds, testimonies and statements), directly or via third-party appointees, within the context of the project JUST EU and ME funded by the European Union's Citizens, Equality, Rights and Values (CERV) Programme, shall be processed, mainly by electronic means, by European Movement International - the data controller - with an office at Place du Luxembourg 2, 1050 Brussels, Belgium, having received prior consent.

The purposes of data processing are related to management, accounting reports to donors and the evaluation of the project's activities as well as, mainly with regard to the images, sounds and testimonies; the partial or total processing with a view to creating other communication materials and instruments for public consumption, even in conjunction with previously available content in order to promote and document the institutional initiatives, projects and activities. The data acquired shall not be used for any other purpose and shall be processed and filed in compliance with the national and European regulations that are mandatory and required for said purposes. Furthermore, the data collected (images, sounds and testimonies) will be transferred to project partners who, according to the contract, operate and work on the same areas of intervention as European Movement International. Without consent to the transfer of this data, it will not be possible to proceed with the registration and implementation of project activities.

Pursuant to articles 9 and 10 of European Regulation 2016/679 (GDPR) one may confer data which qualifies as "special categories of personal data" (art. 9, paragraph 1, GDPR: "personal data that reveals racial or ethnic origin, political opinions, religious or philosophic beliefs or trade union membership. It also refers to the processing of genetic data, biometric data used to identify a specific natural person, data on health or a person's sex life or sexual orientation"). This data may be legally processed by us exclusively following free and explicit consent (art. 9, paragraph 2, letter a), GDPR).

The personal and identification data collected shall only be held for the time necessary for the completion of the project in its various stages and other instrumental activities (accounting and evaluation). Images, sounds and testimonies shall instead be kept on our files for as long as the communication activities and the context of the footage shall be objectively significant to represent the event and our relationship with audiences and the institutional activities and projects which we are engaged in. They shall be subsequently erased by destruction and shall no longer be recoverable or ascribable to the persons involved. Said materials may, on the other hand, be kept further following an express request by supervisory organisms, the judicial authorities, the police and in order to assert or defend rights in court, both on behalf of our association, as well as any of the subjects involved in the filming.

The persons authorised to process the data for said purposes are members of staff working on the project and our associations institutional and communication activities, as well as those responsible for our IT systems and data security.

Pursuant to articles 15-22, GDPR, by writing to the data controller at the above address or by e-mail to secretariat@europeanmovement.eu one can request a complete and updated list of data processors and exercise the rights of consultation, modification, cancellation and the "right to be forgotten", as well as impose limitations to the processing of data or oppose said processing for legitimate reasons or for information and promotional purposes, also limited to one or more contact tools (e.g.: by e-mail and/or sms and/or post and/or telephone). If not specified, the objection to the processing of data for information purposes shall be deemed to extend to all means of contact. Any revocation of the consent given, which may be submitted at any time, shall not affect the lawfulness of the processing based on the consent previously given or on alternative mechanisms to consent permitted by law.

#### Request for authorisation to use and disseminate the images and sounds and testimonies

With reference to the prescriptions of art. 10 of the Italian Civil Code relative to the abuse of the image of others, European Movement International guarantees that the testimonies and statements, sound and images will only be disseminated for purposes that are allowed by current legislation, as well as respecting the decorum, dignity and reputation of the persons involved. I acknowledge that European Movement International may not be held liable for any damaging consequences that may result from the dissemination of testimonies and statements, sounds, images and/or photos that refer to the minor, that may be ascribed to violations committed by third parties outside the control of our association. The undersigned acknowledges that no fee shall be owed as a result of the use and dissemination of the testimonies and statements, the images and the sounds in question, nor any other kind of economic or other remuneration. By applying my signature for consent, I hereby authorise and approve what is detailed above regarding the responsibility to disseminate the filmed testimonies, sounds and image and authorise the use and dissemination of these images, testimonies and sounds for the purposes detailed in the information notice provided.
